Summer Internship Programme 2024

Dear Graduate Recruitment Manager,

I am a third year law student at Trinity College Dublin, currently studying abroad at Maurer School of Law, Indiana University Bloomington, and I am writing to apply for the 2024 Summer Internship Programme with ByrneWallace. I am interested in ByrneWallace for a variety of reasons. Firstly, I am extremely aware of the strong reputation of the firm, which was further highlighted by its award of Irish Pension Law Firm of the Year at the Irish Pensions Awards last year and the fact that the firm was a finalist in the Northern Ireland Dealmakers Awards of 2024.

Additionally, being a member of FLAC keeps me updated on issues facing marginalised groups in society and encourages me to increase my awareness of social justice matters and to use my voice to speak up for injustice. I believe in the importance of providing access to everyone and I am encouraged by the commitment of ByrneWallace to this mission as well.

At present, in my third year of studying law, I am interested in the Financial Services sector of ByrneWallace, with a particular focus on the practice areas of Corporate Crime and Banking and Finance. As part of my study abroad programme, I have been given the opportunity to study modules that are not currently offered at my home university, such as Financial Regulation and Antitrust Law. Since taking these classes, I have developed a strong interest in these areas. Furthermore, this semester, I am taking Corporate Finance and Health Privacy Law, among others. Therefore, ByrneWallace is of particular interest to me due to the strength of the firm's expertise and focus in these legal fields.
