- A paper examining whether the 1951 Refugee Convention accommodates for stateless asylum seekers in pursuing claims for refugee status.
- A paper examining the deliberate crime of starvation in non international armed conflicts such as in Yemen, Syria and South Sudan, and an analysis of the potential power of the International Criminal Court's latest amendment to the Rome Statute to prosecute for such crime in this context.

My Master's dissertation is centered around European foreign terrorist fighters who have travelled to Syria and Iraq to join ISIS. It critically analyses the security threat that foreign terrorist fighters pose to Europe upon their return and it uncovers the legal responses of Belgium, France and the UK to the homecoming of this cohort. I created a comprehensive and contemporary dataset of terrorist attacks committed by ISIS affiliates in Europe from 2014 until June 2020. I received a 1:1 grade in my dissertation.
