This inspired my decision to undergo Erasmus placement to Germany, where I planned to develop German as my second language. I was thrust into an unfamiliar environment and still managed to exceed the expectations I had set myself, developing new skills and gaining new friends along the way. I tried as much as possible to incorporate yoga and mindfulness into my routine as I found it helped me to ground myself through the struggle of living outside of my comfort zone and is now a practice I have maintained in my daily life. As a result of my time in Germany, I also enjoy listening to podcasts on German news and politics.

From childhood, I cultivated an interest in law through watching series such as "Murder, She Wrote" early on a Saturday morning. This developed into an interest in debate in both English and German during my time at secondary school and subsequently blossomed into the desire to represent those who required a voice louder than their own. My early interest in law and representation guided my choice of study at university level.

I feel that my interest has translated academically as I was awarded scholarships for my results in my first, second and final year of university where I achieved first honours and came within the top 10 of my class. I fulfilled my passion to help when I began volunteering as a leader with the university's CÉIM Programme which is a Peer Learning system aimed to make the transition into the first year of college more comfortable and accessible. I volunteered in my second year of college after seeing the benefit of it as a first-year student and was then asked to return when I came back to university in my final year which I was grateful for. This experience offered me the opportunity to gain a better understanding of legal skills while developing connections and teamwork skills. My effort was recognised and culminated in the strong recommendation for me to apply for their graduate internship where I am currently working after being successful at interview.
