I have been awarded five FE-1 exams to date and aim to complete the remaining three exams in October 2019. I have a Master's degree in Political Science and Public Policy from Trinity College Dublin. This illustrates my capacity to plan projects in detail and to anticipate problems.

I feel that I have the right skill set to excel at your firm in terms of interpersonal and communication skills for client engagement, problem solving and attention to detail. I currently work for Brown Brothers Harriman & Co. which has given me an insight into the financial services sector. I manage internal and external communications for the Managing Director of BBH Fund Administration Services. I record minutes at Senior Management Committee meetings which are submitted to the Central Bank of Ireland as part of their PRISM Engagement meetings with the Firm.
