I wish to apply for a traineeship with Byrne Wallace. I am pursuing a career as a commercial solicitor after a year of practical legal experience. I graduated with a BCL degree from UCD achieving fifth place in my class with a high 2:1. I have also recently completed all eight of my FE-1 examinations.

It became clear that a policy regarding BYOD needed to be drafted. I was delighted to draft same and it will now be included in the latest employee handbook to be released by the end of the year. Thus my rewarding experience at Bimeda has solidified my decision to qualify in a commercial firm.

While at secondary school the humanitarian aspect of the law drew my attention to the profession, my interest in commercial law first developed at university. In second year I excelled in an EU Economic Law module obtaining an A+. I consequently decided to attend the Universita Luigi Bocconi, in Milan on Erasmus as it is one of the leading business universities in Europe.
