I am particularly proud of my forthcoming publication in the Irish Judicial Studies Journal titled "Data Protection and the Exercise of the Judicial Function in Ireland". I have also contributed to the case summaries in the Annual Report of the Supreme Court for 2019, which was published in February 2020.

My hobbies, as well as my volunteering activity in promoting LGBT+ organisations mentioned above, include non-professional surfing and swimming. Furthermore, I think it is important to nurture a role in the social and political life of the community, and for that reason I was involved as class-representative in high school, and later in University as legal representative for a student union list.
