Dear Beth Onslow and the Trainee Recruiting Committee,

My name is Magdalena Jasinska and I am writing to you today to apply for the ByrneWallace Trainee Solicitor Programme.

My journey to this point has not been conventional. I was born and grew up in Poland where I studied up to Matura, (the Polish equivalent of the Leaving Certificate). After finishing school in Poland, I decided that I wanted to avail of further education and potential employment opportunities in Ireland, which at the time, showed greater prospects and were more promising than what was on offer in Poland.

In order to apply for university, I realised that I would need to sit the Leaving Certificate exams as the CAO could not convert my Polish examination results. At Insomnia, I assisted the CFO with the financial restructuring of the company, GDPR audits and other company secretarial matters. In my current role at Arthur Cox, I have been allocated more senior responsibilities within the team including detailed quality control reviews of work completed by junior team members. I have also been entrusted with assisting in the management of two remediation projects with minimum supervision and have received encouraging feedback on both my project and time management skills.
