Throughout my time in LawPlus I have shown a distinct aptitude for law and know that this is an area in which I have demonstrable ability and skill that would be of benefit in any legal environment. My particular interest is in contentious litigation, where my eye for strategy puts me in a very strong position. Recently, I have demonstrated my commercial awareness in the GradIreland National Student Challenge. This competition is sponsored and part-organised by Ireland's largest professional services firms and seeks to identify candidates who demonstrate commercial awareness, teamwork and leadership abilities and the potential to thrive in Ireland's commercial and professional services sector. I have enjoyed great success in this competition, reaching the national finals in 2013, 2014, and 2015 and ranking third overall (and the top-ranked TCD student) in 2015. I am currently ranked third overall and again the top-ranked TCD student in the opening stages of the 2016 competition.

This mix of experiences and skills puts me in a unique position. I am enthusiastic and motivated to pursue a career in law and I have the skills and the ability to thrive in the pressured environment of a large and growing law firm. I very much look forward to starting that journey with ByrneWallace.
