Born in Damascus, Syria, but raised in Jordan, I studied law at the University of Jordan and received first class honours in my undergraduate degree in 2009. In 2011, I won a full scholarship to the College of Europe, Bruges, where the subject of my Master's thesis was "Parent Company Liability in Case of Subsidiary Insolvency". I trained with the international law firm, Eversheds, in Amman and was hired into the corporate department in 2013 upon qualification. My work was primarily through English, although Arabic is my native tongue. I am also proficient in French; my LLM was through both English and French and subsequently I lived in Brussels for a year.

I came to live in Ireland in 2014 with my Irish husband. While settling into life in Dublin, I did freelance translation and project work through Eversheds Amman with Yahoo Dublin.
