Dear Colleague,

I write to ask for your support in this year's Law Society Council elections.

Background: I grew up in Donegal and qualified as a solicitor in 1994. I practiced in Northern Ireland and England for five years before returning to Ireland and joining the Law Society of Ireland in 1999, when I joined ByrneWallace. I have been the Law Society Junior Vice President and I am a member of the Co-ordination Committee. These roles involve representing the Law Society externally and key decision making within the Law Society.

Securing the Society's finances: I chaired the Finance Committee during the past recession, and remain a member, working to secure the Society's finances in the most difficult times. I now chair the Audit subcommittee.

Excellence in professional education services: I previously chaired the Education Committee, ensuring the quality and scope of education for trainees and qualified solicitors. Next year will see the continuing effect of Covid-19 on people's lives, their finances, the legal system and business nationally and internationally.
